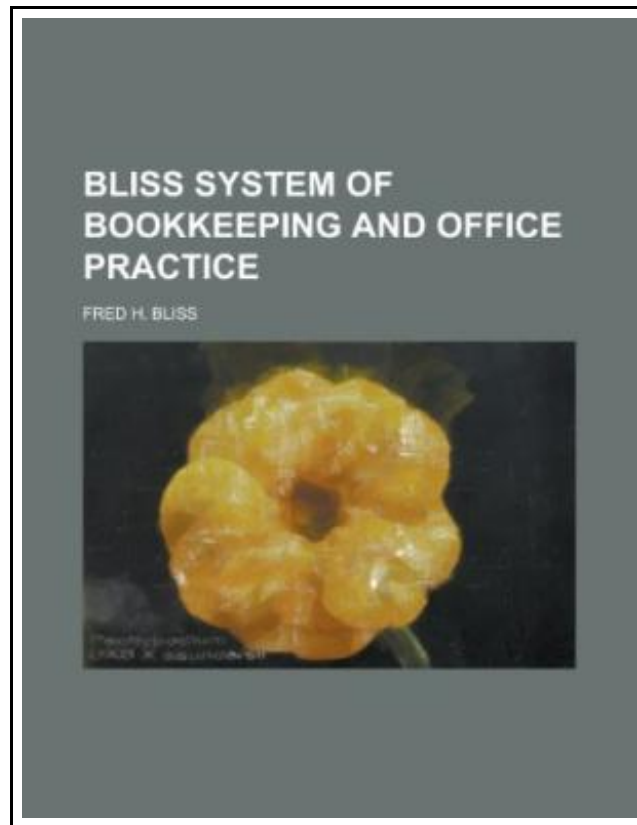

As a result, small-business owners must take time and resources out of their business to prove they are not liable for whatever wrong was theoretically committed. As one small-business owner remarked to me last year, What happened to the idea that in this country you are innocent until proven guilty Although that mantra refers to a defendants rights in our criminal justice system, problems with our civil justice system can no longer be ignored. It is incumbent upon the attorney representing a plaintiff to get the facts straight before sending a threatening letter or filing a lawsuit, not after the letter is sent or the lawsuit is filed. Sadly, due in large part to the ineffectiveness of Rule 11 in its current form, we have a legal system in which many plaintiffs attorneys waste resources and...
