

The intention is to be collected, not from any particular or detached clause of the will, but from the whole taken together, and from any codicil which forms a part of it. Every word is to have its effect, provided an effect can be given to it not inconsistent with the general intent of the whole will taken together, for a testator is not to be supposed to have used words without meaning, if it is possible to give them a consistent meaning; and the rule is not to reject any words, unless there can not be any rational construction of these words as they stand.
